



INVESTMENT STRATEGY AND PROCESS

Lester Asset Management Inc. ("LAM") launched an actively managed All-Cap Canadian Equity strategy for its segregated accounts in July 2006 and created a pooled version through the LAM Canadian Equity Fund (the "Fund") in January 2012. The strategy's aim is to be different from the S&P/TSX Composite Index and achieve higher returns than the market with lower risk as measured by low market correlation, low cyclical exposure, and better industry diversification. The portfolio is invested in 40 to 50 small, mid and large cap Canadian listed companies selected using a research process based on fundamental bottom-up analysis, strict quantitative and qualitative criteria, and a sound understanding of each company and the industry in which each operates, complemented by a macro-economic outlook. The investment style is value-driven and opportunistic, seeking to buy shares at a discount to a company's true worth, with the goal of maximizing shareholder value through dividend growth, share buybacks, spin-offs or an outright sale.

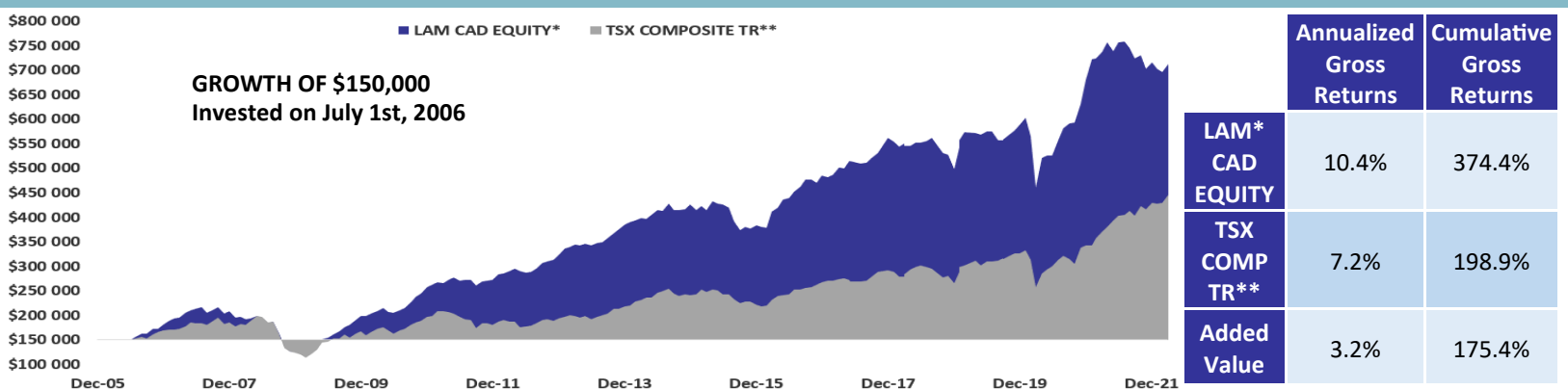

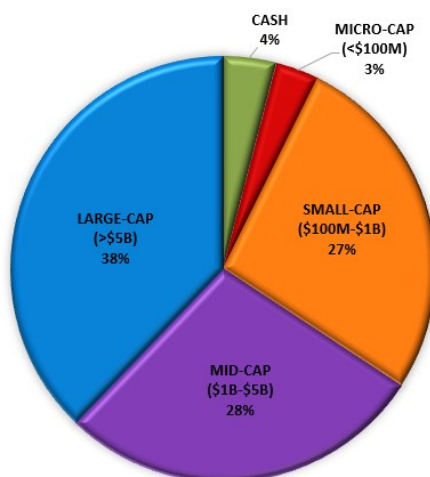

MONTHLY COMMENTARY

The **LAM Canadian Equity Fund** increased **+2.2%** on a gross basis versus +4% for the TSX Composite Total Return. Most world stock markets rose after sharp declines in prior months, but remain deeply in the red year-to-date, with the S&P500 and NASDAQ down -5.9% and -10.1% respectively, and the MSCI Europe, Far East and Emerging Markets down -8.3%, -6.8% and -8% respectively, in Canadian dollar terms. Persistent inflation caused by ongoing supply chain disruptions and higher energy prices aggravated by Russia's war on Ukraine, are pressuring central banks to increase interest rates more aggressively. The TSX Composite moved back into positive territory year-to-date due mainly to the Gold sector surging +11.2% and the Energy sector gaining another +6.6%. Our underperformance was again due to our lack of exposure to gold stocks and lower weightings in the Energy and Consumer Staples sectors. Our top contributors included **Canadian Pacific Railway**, agricultural equipment maker **Ag Growth International** which released strong results, and **Boralex** which is expected to benefit from increased investments in renewable energy in Europe where it has a strong presence. Detractors included instant lottery ticket provider **Pollard Banknote** which, despite having record sales volumes, is having to absorb higher input costs, and a few of our technology holdings. We are mindful of the effects of inflation, geopolitical risks in Eastern Europe, and a likely economic slowdown due to rising interest rates, and remain well diversified in mostly recession-resistant businesses. Most of our holdings have been reporting record financial results and are trading at reasonable valuations, giving us confidence that these will perform well going forward. We have also been taking advantage of market volatility to invest in quality companies at attractive prices which should provide the portfolio with strong long-term returns.
