RESPONSIBLE GROWTH

INVESTMENT STRATEGY AND PROCESS

Lester Asset Management Inc. ("LAM") launched an actively managed All-Cap Canadian Equity strategy for its segregated accounts in July 2006 and created a pooled version through the LAM Canadian Equity Fund (the "Fund") in January 2012. The strategy's aim is to be different from the S&P/TSX Composite Index and achieve higher returns than the market with lower risk as measured by low market correlation, low cyclical exposure, and better industry diversification. The portfolio is invested in 40 to 50 small, mid and large cap Canadian listed companies selected using a research process based on fundamental bottom-up analysis, strict quantitative and qualitative criteria, and a sound understanding of each company and the industry in which each operates, complemented by a macro-economic outlook. The investment style is value-driven and opportunistic, seeking to buy shares at a discount to a company's true worth, with the goal of maximizing shareholder value through dividend growth, share buybacks, spin-offs or an outright sale.

MONTHLY COMMENTARY

For the month of March, **LAM Canadian Equity Fund** rose by **+2.0%** on a gross basis versus **+4.1%** for the TSX Composite Total Return. Year-to-date, the Fund is up **+5.8%** versus **+6.6%** for the TSX. World equity markets rose once again on continued optimism about an end to the rate hiking cycle and positive economic data, despite the U.S. Federal Reserve and the Bank of Canada indicating that rate cuts would be delayed until later in the year. Our underperformance versus the TSX was mainly due to our low weightings in the Gold and Energy sectors, which rose **+18.2%** and **+9.3%** respectively, as well as our higher cash weighting. Our top contributor was e-commerce and government e-procurement solutions provider **MDF Commerce** which rose by 56% after receiving a takeover offer from private equity giant KKR. Other contributors included supply chain solutions provider **TECSYS**, intelligent transportation systems leader **Quarterhill**, agricultural equipment manufacturer **AG Growth**, and **Bank of Montreal**. Detractors included vitamin maker **Jamieson Wellness**, funeral home operator **Park Lawn**, automation systems integrator **ATS**, and **Telus**. We continue to have a positive view of equity markets now that interest rates have stabilized and will eventually decline, yet employment remains strong. However, we are being very selective about what sectors and companies we are investing in, and remain cognisant of numerous risks including a slowing economy and volatile geopolitics. Our portfolio remains well diversified and invested in economically resilient growing businesses trading at reasonable valuations which should allow us to keep generating attractive risk-adjusted returns.
