INVESTMENT STRATEGY AND PROCESS

Lester Asset Management Inc. ("LAM") launched an actively managed All-Cap Canadian Equity strategy for its segregated accounts in July 2006 and created a pooled version through the LAM Canadian Equity Fund (the "Fund") in January 2012. The strategy's aim is to be different from the S&P/TSX Composite Index and achieve higher returns than the market with lower risk as measured by low market correlation, low cyclical exposure, and better industry diversification. The portfolio is invested in 40 to 50 small, mid and large cap Canadian listed companies selected using a research process based on fundamental bottom-up analysis, strict quantitative and qualitative criteria, and a sound understanding of each company and the industry in which each operates, complemented by a macro-economic outlook. The investment style is value-driven and opportunistic, seeking to buy shares at a discount to a company's true worth, with the goal of maximizing shareholder value through dividend growth, share buybacks, spin-offs or an outright sale.

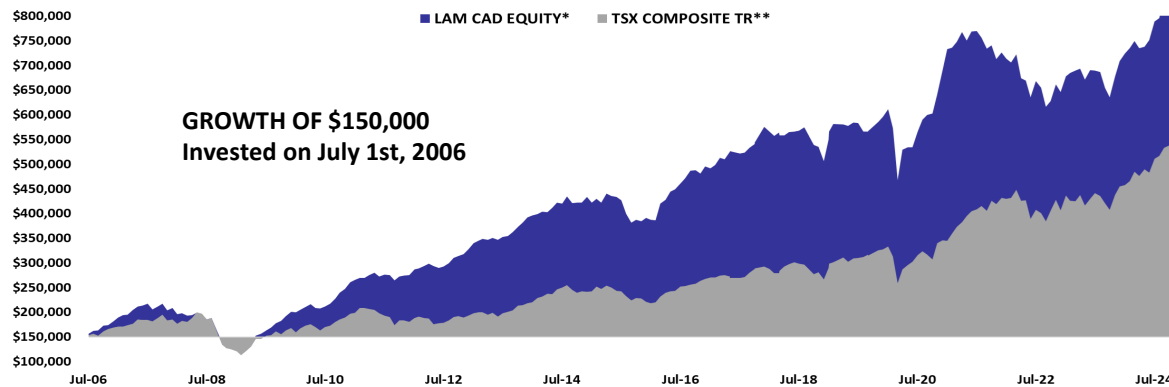

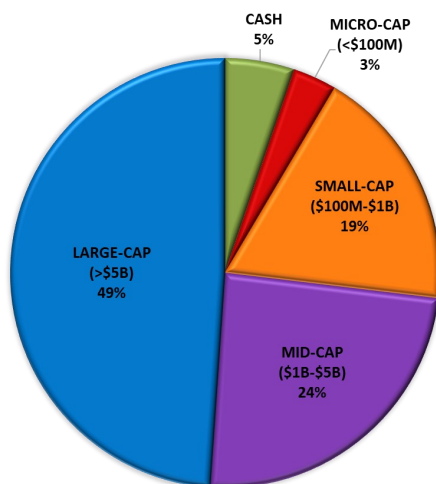
CUMULATIVE GROSS RETURNS VERSUS TSX COMPOSITE TR** SINCE JULY 1, 2006

MONTHLY COMMENTARY

For the month of October, the **LAM Canadian Equity Fund** declined modestly by **-0.1%** on a gross basis versus a rise of **+0.8%** for the TSX Composite Total Return. Year-to-date, the Fund is up **+18.2%**, similar to the TSX, despite our portfolio having low weightings in the Materials, Financial and Energy sectors which have been the main drivers of the TSX return this year. Both stock and bond prices were volatile during the month due to uncertainty around the U.S. elections and strong economic data which put in doubt the pace of further interest rate cuts by the Federal Reserve. As a result, most world stock markets declined with the S&P500, MSCI Europe, and MSCI Far East indices losing -0.9%, -5.9% and -4% respectively in local currencies. Our underperformance versus the TSX was due to our lack of exposure to gold stocks, and low weightings in the volatile Materials and Energy sectors which rose +3.7% and +3.2% respectively, helping to keep the TSX in positive territory for the month. Among our top contributors were space technology company **MDA**, industrial valve maker **Velan** which rose on the announcement of a nuclear valve contract, global engineering firm **WSP Global**, discount retailer **Dollarama**, **BMO** and **Canadian Western Bank**. Our main detractors included instant lottery ticket supplier **Pollard Banknote**, agricultural equipment manufacturer **Ag Growth**, renewable power producer **Boralex**, intelligent transportation solutions provider **Quarterhill**, and railways **Canadian Pacific Kansas City** and **CN Rail**. Considering the significant pullback in equity markets worldwide, we were pleased with our near break-even return for the month. Despite economic and geopolitical uncertainties following the U.S. election results, we remain bullish on Canadian equities going forward and continue to hold a diversified group of low economically sensitive companies trading at reasonable valuations in order to keep producing steady and attractive risk-adjusted returns
